

**Minutes of the Regular Arcola City Council Meeting  
Monday, January 3, 2005**

**APPROVAL OF DECEMBER 17 – DECEMBER 31, 2004 BILLS** Alderman Ferguson moved to approve the December 17 – 31, 2004 Bills as presented and was seconded by Alderman Williams. Roll call vote, Lampe, aye; Kile, aye; Williams, aye; Ferguson, aye; Wheeler, aye; Gentry, aye. Motion carried.
