APPROVAL OF MARCH 04, 2019 COUNCIL MEETING MINUTES Alderman Smith moved to approve the March 04, 2019 council meeting minutes as presented and was seconded by Alderman Foran. Roll call vote, all ayes. Motion carried.

APPROVAL OF MARCH 02, 2019 – MARCH 15, 2019 BILLS Alderwoman Huckstep moved to approve the March 02, 2019 – March 15, 2019 bills as presented and was seconded by Alderman Hensley. Roll call vote, all ayes. Motion carried.

REPORT FROM THE PLANNING COMMISSION The Planning Commission met March 11th, reviewed and recommended the council approve a request from Reynaldo Gonzalez and Marisol Vega to rezone property located at 402 E. Springfield Rd. from B-1 General Commercial to R-4 Multi-Family Residential. Alderman Foran moved to refer back to Planning Commission for further review and was seconded by Alderwoman Huckstep. Roll call vote, Hensley, aye; Ferguson, aye; Guyot, nay; Foran, aye; Huckstep, aye; Smith, nay. Motion carried.

CONSIDER AND APPROVE ORDINANCE NO. 19-C-2, AN ORDINANCE AMENDING CHAPTER 22 OF THE ARCOLA MUNICIPAL CODE Alderman Foran moved to approve Ordinance No. 19-C-2 and was seconded by Alderman Smith. Roll call vote, all ayes. Motion carried.

CONSIDER AND APPROVE RENEWAL OF EMPLOYEE DENTAL INSURANCE WITH DELTA DENTAL Alderwoman Ferguson moved to approve renewal of employee dental insurance with Delta Dental with no changes and was seconded by Alderman Foran. Roll call vote, all ayes. Motion carried.

CONSIDER AND APPROVE RENEWAL OF EMPLOYEE HEALTH INSURANCE WITH BLUE CROSS BLUE SHIELD OF ILLINOIS Alderwoman Ferguson moved to approve renewal of employee health insurance with Blue Cross Blue Shield of Illinois. Alderman Foran seconded the motion. Roll call vote, all ayes. Motion carried.
