Monday, June 04, 2012**

APPROVAL OF MAY 21, 2012 COUNCIL MEETING MINUTES Alderman Goad moved to approve the May 21, 2012 council meeting minutes as presented and was seconded by Alderwoman Key. Roll call vote, all ayes. Motion carried.
