<u>CONSIDER AND APPROVE PAY REQUEST NO. 2B TO B & T DRAINAGE – SANITARY SEWER REPLACEMENT</u> Alderman Guyot moved to approve Pay Request No. 2B to B & T Drainage Sanitary Sewer Replacement in amount of \$31,955.80. Alderman Reece seconded the motion. Roll call vote, all ayes. Motion carried.

<u>CONSIDER AND APPROVE THE PURCHASE OF A 2016 FORD UTILITY</u>
<u>INTERCEPTOR</u> Alderwoman Key moved to approve the purchase of a 2016 Ford Utility
Interceptor in the amount of \$21,368 for the police department. Alderman Reece seconded the motion. Roll call vote, all ayes. Motion carried.
